

**IOWA STATE UNIVERSITY
2000 DRINKING WATER CONSUMER CONFIDENCE REPORT**

This document is intended to inform Iowa State University water consumers about their drinking water. Information provided in this publication represents a snapshot of 1999 water quality data. Included are details about where your water comes from, what it contains, and how it compares to the United States Environmental Protection Agency (EPA) and state standards.

SOURCE OF WATER

Iowa State campus drinking water comes from underground wells owned by the City of Ames. The wells are 87 to 150 feet deep. The City of Ames treats the raw well water and then pumps it to Iowa State University's underground piping system.

CONTAMINANTS AND HEALTH EFFECTS

Drinking water, including bottled water, may reasonably be expected to contain small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in raw well water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum productions, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or the result of oil and gas production and mining activities.

Some people may be more sensitive to contaminants in drinking water than the general population. Immuno-compromised individuals can be particularly at risk from infection. This includes someone who has undergone chemotherapy, has undergone organ transplants, has HIV/AIDS or other immune system disorders, is elderly, or is an infant. These individuals should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection are available from the Safe Drinking Water Hotline (1-800-426-4791).

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

DEFINITIONS USED IN CONTAMINATE SUMMARY

MCL Maximum contaminant Level – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG Maximum contaminant Level goal – The level of a contaminant in drinking water below which there is no known or expected risk to health.

µg/L Micrograms per liter; is one part of contaminant per billion parts of water.

Action Level The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which must be followed.

90th Percentile The 4th highest reading from a group of 30 samples. The selection of the highest reading varies with the sample size.

CONTAMINATE SUMMARY

In 1999, 1107 tests for three contaminants were taken for the Iowa State University underground piping system. Of the 1107 tests, one test was at levels higher than the EPA allows. Information about this test is provided in the “Violations” section of this document.

Coliforms are bacteria which are naturally present in the environment and are used as an indicator that other, potentially-harmful bacteria may be present. Coliforms were found in more samples than were allowed and this is a warning of potential problems.

The same samples were then tested and found to be absent for fecal coliform. Repeat samples were taken. All repeat samples were found to be absent for total coliform. Since the repeat samples were negative, no other action was required.
